Millage Resolution | <p>WHEREAS, The Township of Boyne Valley, County of Charlevoix, State of Michigan, has met all the requirements of Section 16 of the Uniform Budgeting and Accounting Act, allowing the levy of the maximum allowable millage greater than the Base Tax Rate to support the 2024-2025 fiscal budget as stated at a public hearing on the proposed budget held on August 26, 2024 at 5:30 pm at the Boyne Valley Township Hall, and</p> <p>WHEREAS, Boyne Valley Township has complete authority to establish the number of mills to be levied from within its authorized millage rate of 4.08 mills total (1 mill Township allocated, 1 mill voted fire protection, .33 mill voted ambulance, .25 mill transfer station and 1.5 mill voted road millage) allowed under "Headlee", and</p> <p>WHEREAS, it is a requirement that an increase resolution be adopted by the Boyne Valley Township Board,</p> <p>NOW THEREFORE, be it resolved that Boyne Valley Township, County of Charlevoix, State of Michigan, levy 4.08 mills to support the 2024-2025 fiscal budget.</p> <p>MOTION by Sparks, to adopt this resolution, supported by Hobbs.</p> <p>ROLL CALL: Sue Hobbs yes Renee Fitzgerald yes Lynn Sparks yes Bernie Kondrat absent Randall Matelski absent</p> <p>Resolution declared adopted this 26th day of August, 2024.</p> |
